

**401a Plan
2-Year Enrollment Window Expiring for many Employees
Informational Sessions Scheduled**

On January 1, 2008 a pre-taxed, supplemental retirement plan, 401(a) Plan was offered to State employees that were 40 years of age, if a member of ASRS and 30 years of age, if a member of PSPRS. This Plan is in addition to the 457 Deferred Compensation Plan available and has a higher limit. The 457 Plan limit is \$16,500 and the 401(a) Plan limit is \$49,000, for calendar year 2009. The IRS however has restrictions on the 401(a), since it is an additional pre-tax plan. One of the restrictions is that there is a two year window, from eligibility date, that you can elect to participant in the Plan. Once you do enroll, your participation is irrevocable, you cannot change the amount of contribution or stop contributing while still working for the State. The two year window will be closing on 12/31/09 for those employees who met the age requirements and were employed on January 1, 2008. Please plan on attending one of the informational sessions to learn about the 401(a) and determine if it is right for you.
