Dear Governor Hobbs, President Petersen, and Speaker Toma:

Pursuant to Arizona Revised Statutes § 41-751, the Arizona Department of Administration (ADOA) is providing you with the 2024 State Personnel System (SPS) Workforce Report. You also can view this and past years' reports at <a href="https://hr.az.gov/content/publications">hr.az.gov/content/publications</a>.

Notable highlights for Fiscal Year (FY) 2024 include:

• Average salaries rose slightly as agencies identified opportunities to incentivize and recognize staff within their current appropriations. However, the increase of 1.4% was still well below the increase in the Consumer Price Index (CPI) of 3.0% during the same period as well as the 4.1% average percentage salary increase for public and private sector employers per Willis Towers Watson, a leading employee compensation consulting firm.

- Cabinet agencies were able to reduce overtime expenditures by nearly \$1,700,000 from FY 23 despite a significant increase of over \$900,000 at the Department of Forestry and Fire Management in response to a busier-than-usual fire season. This was led by a reduction of overtime at the Department of Corrections, Rehabilitation and Reentry of over \$1,500,000.
- The pilot program for Paid Parental Leave has shown promising results with 98% of employees who participated in the program having remained with the State.

The State's remote work policies continue to play a significant factor in recruitment and retention, with 94% of employees responding that remote work has had a positive impact on their work experience in the most recent employee engagement survey.

We hope the information provided in this report will assist in decision making regarding Arizona state government and its employees. As always, the ADOA team and I are available to answer any questions you may have.

# State of Arizona Fiscal Year 2024 Workforce Report

**State Personnel System** 

Arizona Revised Statutes (A.R.S.) § 41-751 requires the Director of the Arizona Department of Administration (ADOA) to provide an annual report to the Governor and the Legislature on state personnel and the operation of the State Personnel System (SPS).

Pursuant to applicable federal and Arizona State law, ADOA administers the system by establishing statewide policies and procedures and providing support to individual agencies and oversight of their personnel management. Agencies outside SPS have the authority to develop their own employee-related policies and practices.

The table below identifies the number of active SPS employees as well as employee counts for each state agency (excluding the universities and Board of Regents) that operate their own personnel systems<sup>1</sup>. The remainder of the information contained in this report provides information related to SPS employees only.
